Who's Coming to Camp?

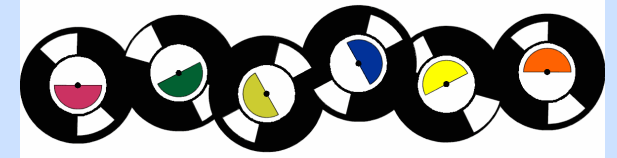
